Eligibility/Motorcycle Requirements:

All motorcycle enthusiasts are encouraged to attend, however, to be eligible to enter into one of the available categories motorcycles must meet the outlined selection criteria found on the entrant application:

Safety Regulations:

All entrants must adhere to the outlined laws, regulations and safety regulations. Failure to follow reasonable instructions, signed or directed by a designated official, may result in exclusion from this and/or future Aussie Viclas Events.

As this event will also contain the use of public roads and spaces all participants are advised to;

- a. Ensure motorcycles are in safe working condition, including brakes, lights, and signals.
- b. Follow all traffic laws and regulations during the event.
- c. Observe and respect any additional safety guidelines provided by the event organizers.

The responsibility for adhering to these guidelines falls solely on the participant.

Behaviour Expectations:

Participants are expected to conduct themselves in a respectful and responsible manner throughout the event, both on and off their motorcycles.

Any behaviour that is considered disruptive, dangerous, or inconsiderate towards others is strictly prohibited.

Definition of Bad Behaviour or Antisocial Behaviour:

Bad Behaviour or Antisocial Behaviour includes but is not limited to:

- a. Engaging in hooning, reckless riding or stunts that endanger oneself or others.
- b. Verbal or physical harassment, discrimination, or intimidation of other participants, spectators, or staff.
- c. Vandalism or damage to property.
- d. Public intoxication.
- e. Any illegal activities or actions that violate local laws and regulations.

Penalties and Consequences for Bad Behaviour or Antisocial Behaviour for participants:

If an entrant is found engaging in bad behaviour or antisocial behaviour, the following actions may be taken:

- a. Verbal warning by event staff.
- b. Temporary suspension from participating in the event.
- c. Permanent expulsion from the event without refund.
- d. Potential exclusion from future events
- e. Legal action and reporting to the appropriate authorities, if necessary.

Penalties and Consequences for sponsors:

Violation of this agreement may result in penalties outlined above, or additional consequences as determined by the event organizers. These may include, but are not limited to:

- a. Published and Public Acknowledgement of the breaches
- b. Revocation of Awards or Prizes.
- c. Restriction from participating in future events organized by the same entity
- d. Legal actions, if warranted.

Dispute Resolution:

Any disputes or conflicts between the event organizers, entrants and sponsors shall be resolved through amicable discussions and negotiations.

Photography, Videography, and Media Coverage:
